- SECTION 3 That the authorization herein conferred shall extend to any advances for the year 2015 tax year that may be required to be paid in calendar year 2017,
- SECTON 4 The Village Fiscal Officer be and is hereby authorized and directed to forward a certified copy of this Resolution to the Summit County Fiscal officer as may be necessary to make this Resolution effective,
- SECTION 5 This Resolution shall take effect and be in force from and after the earliest period allowed by law,
- SECTON 6 That this Council hereby finds and determined that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council which resulted in formal action were taken in meeting open to the public, in full compliance with the with the applicable legal requirements including Section 121.22 of the Ohio Revised Code.
