WHEREAS, the Council of the Village of Boston Heights wishes to support the 2018 Annual Fall Festival held in the Village park, and,

WHEREAS, the Council of the Village of Boston Heights wishes to set a budget amount for the 2017 Fall Festival in the amount of \$2000.00.

NOW, THEREFORE, be it resolved by Council of the Village of Boston Heights, Summit County, Ohio, as follows:

Section 1: That the Village hereby supports and sponsors the 2018 Annual Fall Festival to be held at the Village park on October 13, 2018.

Section 2: We, the Council of the Village of Boston Heights, do hereby appropriate the following amount for the 2018 Annual Fall Festival: \$2000.00.

Section 3: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.


