A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH OHM ADVISORS, AN INDEPENDENT ENGINEERING COMPANY, REGARDING THE DESIGN AND BID ADMINISTRATION FOR PHASE 1 AND PHASE 2 OF THE BOSTON MILLS ROAD RECONSTRUCTION PROJECT, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Boston Heights previously issued a request for professional services related to the design and bid package administration process for the Village’s Capital Improvement Program, which included several local street paving programs; and,

WHEREAS, the Village has evaluated the qualifications of the firms responding to the Statement of Qualification request based upon their competence, ability in terms of workload and availability of qualified personnel, their experience, their past performance with respect to quality of work, and satisfaction of deadlines and prior experience working with the Village; and,

WHEREAS, OHM Advisors has submitted a proposal for the design and bid package in process for the Boston Mills Road Reconstruction Phase 1 and Phase 2 Projects, attached as Exhibit “A.”

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Boston Heights, Summit County, Ohio as follows:

Section 1: That the Mayor is hereby authorized and directed to enter a Memorandum of Agreement with OHM Advisors, an independent engineering company, (the “Agreement”), regarding the design and public bid administration for the Boston Mills Road Reconstruction Project as follows: Phase 1 (Boston Mills Road from the intersection of Olde 8 Road and Boston Mills Road West, 1,800 ft; Olde 8 Road (Boston Mills Road to 600ft north, west side); and, Phase 2 (Boston Mills Road (1,800 ft west of the intersection of Olde 8 Road to 525 ft west of Boston Mills Road) Projects.

Section 2: That the Mayor and/or Fiscal Officer are hereby authorized and directed to make payments to OHM Advisors as set forth under the Agreement, as executed.


Section 3: That the Council hereby appropriates the funds necessary for the Agreement, as executed.

Section 4: That it is determined to be in the best interests of the Village and its residents to enter into this Agreement.

Section 5: That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements including Section 121.22 of the Ohio Revised Code.

Section 6: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the Village's residents to allow for the timely preparation of design materials and bid packages to that the project construction can be completed during the proper season and no further delays will occur, and to allow for the continued operations of the Village Service Department, and shall therefore take effect and be in force from and immediately after its passage.
